AGENDA ITEM #2: RECREATION REPORT

March was a fun and exciting month in Recreation Services. We spent the month preparing for our April Easter event and jump-starting our hiring. We attended the El Dorado Union High School District Career fair. We were able to talk to many students about hiring opportunities, as well as volunteer opportunities. We also had our first hiring event. Participants and parents attended, allowing us to meet with parents as part of the process as well. We offered 10 people seasonal positions in Aquatics or as Recreation Leaders. We will have another hiring event on April 18th.

In March, we also received notification that the grant application Kimberly submitted in December was awarded. The grant is through Department of Developmental Services to increase Social Recreation opportunities throughout the state. As part of the \$99,995 grant, we will create inclusive programs including monthly park pop-ups, bi-weekly social skills groups, a monthly teen world explorers' group, and provide specialized training to staff. This is an amazing opportunity that will bring increased revenue, provided targeted programming to an identified underserved population, and place Cameron Park Recreation Services as a leader moving into the future, paving the way for other agencies to follow.

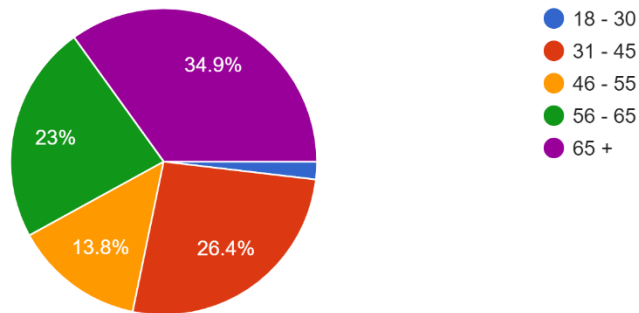
We also spent the month of March creating our Summer Activity guide that is launching in Early April along with the opening of all summer activity registration. We have gone fully digital with printed copies available upon request in person. This is in-line with many other agencies standard of practice and was a necessary move regarding our budget.

We had our first Make & Take class in March. We had 9 participants. They created two crafts, an art project, and played a game. The participants really enjoyed it. The class saw approximately \$130 in net revenue. We are planning a series of these classes over summer.

Our community outreach survey has been available for approximately one month. Below are some of the current results. We have 270 current responses. We have placed it on our website, included in our E-newsletters, posted in every room and bathroom at the community center, pool gates, and emailed to contacts of user groups. We also had flyers at our recent event. We are working on utilizing RecTrac to send the information out as well.

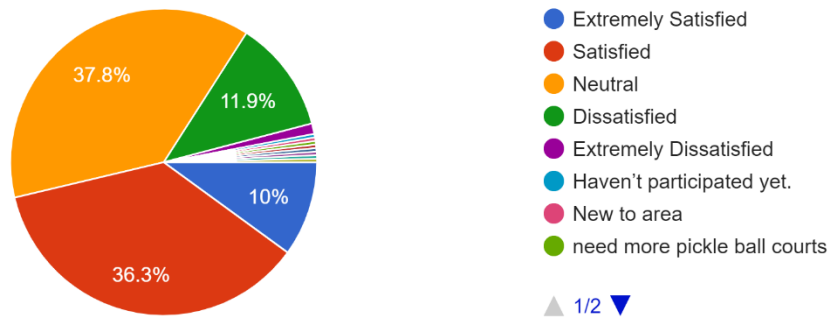
Age

269 responses



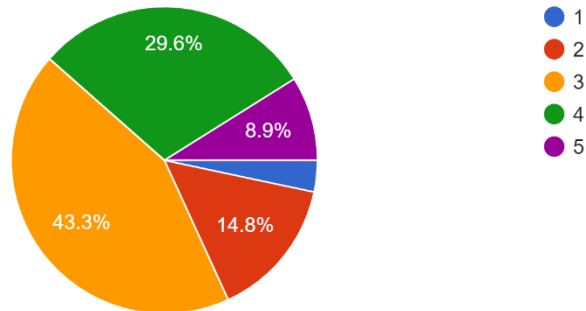
Rate your satisfaction level with Cameron Park CSD

AGENDA ITEM #3: **PARKS & FACILITIES DEPARTMENT REPORT**

RECOMMENDED ACTION: **RECEIVE AND FILE**

General Information

- The week of April 2nd was the first week this year without rain. Staff spent the whole week mowing, fertilizing, and spraying throughout the parks. Staff have a small window to prep all the parks before the spring and summer season arrive.
- The Parks department is down 2 full time staff and 2 part time staff. The department will be scaling back our operations over the next 4-6 weeks while we look to backfill the full-time positions. Expect to see services levels and response times in certain areas impacted by the reduction in staff.
- The Superintendent gave a presentation at the weekly EDCAR (El Dorado County Association of Realtors) meeting with an update regarding the road and culvert repair at Cameron Park Lake. EDCAR rents the Community Center every Thursday morning.
- The department purchased a walk behind Vibraplate for compacting materials such as road base and decomposed granite. These past few storms caused the decompose granite walkways to wash away. This piece of equipment was purchased by the LLAD'S and Parks department budgets. It was cheaper and more convenient to purchase the equipment than to rent it several times throughout the spring.

Cameron Park Lake

- Staff installed the spillway boards in the Lake on Tuesday March 28th as per the DWR (Department of Water Resources) permit. The spill way raises the lake three additional feet.
- Staff installed the new decorative aeration fountains at both inlets of the lake. This project was funded using Quimby's fees.
- The department is working with Cameron Park Rotary to have volunteer's assist District staff with replacing the two-by-six lumber on top of the observation deck. The plan is to have Growlersberg demo the lumber and have district staff repair any dry rot prior to Rotary replacing the two-by-six decking. We will be installing a Trex-like product in place of the original red wood design. Rotary will also be painting the existing guard rail fence. We plan to start this project the week of April 17th. Rotary is planning to donate \$2,000 towards the cost of materials.
- Triangle Well completed the conversion of the old Lagoon well into a usable fire hydrant. The hydrant was operated and inspected by Cal Fire. The hydrant worked flawlessly. EID (El Dorado Irrigation District) has removed the six inch water meet that fed the old hydrant. The six inch meter was costing the district about \$7,000 annually.
- Staff installed the necessary signage on the disc golf course. Baskets for holes #2 and #17 were also relocated. Both items were discussed during the March Parks and Recreation Committee meeting.

Parks and LLAD'S

- A large heritage oak tree that is located next to the restrooms at Christa McAuliffe Park has a large branch with a crack where the branch meets the trunk. Heartwood Tree inspected the large limb and recommended the tree be pruned to reduce the weight. Once the weight reduction is completed, we will then install (3) 5-ton cables to support the tree limb. Heartwood has performed the weight reduction and has order the cables. The playground has been closed since early February due to the cracked limb. We hope to have the cables installed within the next few weeks. If we were to remove the limb the tree would become

unbalanced due to the size of the limb. This could result in further pruning and or removal of the tree.

- Brad Carroll has accepted the full-time Maintenance Worker I position within the parks division. Previously, Brad worked as a part time Maintenance Worker I in the parks division. Brad brings a strong maintenance background, jack-of-all-trade's skill set, and a positive attitude to the division.
- Staff rebuilt the mound and the middle of the infield at Dave West Park. The mound has become worn out over the years and needed to be addressed. Staff removed a large section of turf grass and regraded the mound area. Once level and compacted, synthetic turf will be installed underneath the plastic/fiberglass mound. The synthetic turf will hold up much longer around the mound than natural turf grass.
- Christa McAuliffe soccer field will be closed between April 24th through May 15th for annual maintenance. Staff will aerate, seed, apply pre-emergent and fertilize the field. The field is closed for three weeks to allow the grass seed to germinate.

Community Center

- Currently there is an electrical issue with the underwater swimming pool lights. We are working with National Aquatics to schedule a diver to come out and diagnose the issue. Currently about half of the lights are not working.
- District staff Jeremy Mullins completed training to obtain his CPO (Certified Pool Operator) License. This will give the facilities department an additional staff who can perform more technical maintenance on the pool. Jeremy currently works evenings and weekends which adds flexibility to how and when we maintain the pool.
- Facilities staff assisted recreation with installing new lane line flags above the pool. The old flags were worn out and coming apart.

Cal Fire / Growlersburg

- Growlersberg spent two crew days removing fallen trees at Paul J. Ryan Park.
- Growlersberg spent one crew day chipping a mountain of green waste at Cameron Park Lake.

AGENDA ITEM #5: Pickle Ball at Cameron Park Lake

RECOMMENDED ACTION: Receive, Discuss, and Direct

Introduction

The topic of Pickle Ball at Cameron Park Lake and the issue of noise generated during pickle ball play was discussed during a special meeting of the Board of Directors on March 28, 2023. Following public input and Board discussion, the Board directed staff to bring the item back to the next board meeting (April 19th) to make a decision on the issue of pickle ball noise and recommended ideas for mitigation, which could include, but not limited to, the use of softer balls during pickle ball play, modified hours for pickle ball play, and/or the use of noise-reduction materials that could be placed on the tennis court fence. Suspension of pickle ball play at Cameron Park Lake was also discussed.

Ongoing Efforts

Staff have worked on strategies to help reduce the negative impact pickle ball has on the neighbors at the north end of Cameron Park Lake, which includes limiting access to the Cameron Park Lake courts to authorized hours only, encouraging players to use softer pickle balls, paddles that result in less noise during play, and continue the availability of open gym access at the Community Center.

Options to Endorse

- Suspend pickle ball play at Cameron Park Lake until an alternate venue with adequate courts can be found or built and available for public use. This would require the removal of permanent poles/nets and possible painting over of pickle ball court lines.

- Continue to allow pickle ball play at Cameron Park Lake with stipulations including, but not limited to, equipment that generates less noise, strict adherence to designated hours, and/or the installation of some sort of acoustic barrier that could be used on the chain link fence along the north side of the tennis/pickle ball courts.

Recommended Actions

Until an alternate facility can be developed . . .

- **Continue/adjust defined hours for pickle ball play at Cameron Park Lake.** This would mean engaging the pickle ball community further in adherence to those posted hours, which would also comply.
- **Require the use of softer pickle balls for all play at Cameron Park Lake. If quieter paddles exist, encourage or require the use of those paddles.** A collaborative agreement between the District and pickle ball community could help facilitate this transition.
- **Purchase and install all-weather acoustic blankets/sound barriers to help reduce direct line-of-sight noise.**
- **Continue open gym access for pickle ball play.**
- **Staff recommends that the District continue to look for locations that could accommodate pickle ball play** or that could be developed as a dedicated pickle ball facility. Pickle ball is a growing sport, and as our population ages the sport of pickle ball may increase in popularity. A new Cameron Park pickle ball venue that includes a greater number of courts and quality amenities, such as benches and lighting, would meet the needs of the pickle ball playing community. Should a suitable location be identified, the District should begin developing a financing plan for design, land acquisition (if not on CPCSD property), construction, and maintenance.

Staff does not recommend the suspension of pickle ball play at Cameron Park Lake

- Per County Code Section 130.37.020 – Exemptions: noise sources shall be exempt from the standards of Chapter 17.37 for activities conducted in public parks. That said, staff supports efforts to reduce pickle ball noise without eliminating pickle ball from Cameron Park Lake.
- It would have a negative impact on the pickle ball community which greatly benefits from the physical activity and positive social interaction the participants enjoy.
- Should it become necessary to lock the courts to prevent unauthorized pickle ball play, it would prevent tennis from being played as well when the courts are locked.

AGENDA ITEM #6: **CONDUCT IN PARKS – AMENDMENT OF SECTION 5 OF ORDINANCE NO. 2001-01**

RECOMMENDED ACTION: Review, Endorse and Forward to the Board

Introduction and Background

Public parks are spaces set aside for the use and enjoyment of community members. Parks provide outdoor spaces to play and exercise, and they allow access to the serenity and inspiration of nature. Public parks are spaces managed by agencies, such as the Cameron Park Community Services District, on behalf of the community members it serves. As such, public parks in Cameron Park are the property of the Cameron Park Community Services District, and use of parks is conditional.

On June 6, 2022, staff asked that the Parks and Recreation Commission review and comment on Ordinance No. 2001-01 , Section 5: Conduct Generally, and consider the list of 24 different prohibited activities ranging from making fires to responsibilities of animal owners to the posting of handbills. Staff expressed concern that the list was missing language that would prohibit or restrict activities in Cameron Park public parks for commercial use without the consent or approval of the CSD. Staff recommended that there should be controls over private individuals or businesses using CSD-owned parks in a profit-making venture, regardless of how profitable that venture is. As the CSD owns the parks in this community, staff recommended that the Parks and Recreation Committee consider language that could be used in an amendment to the Section 5 of Ordinance No. 2001-01. The Committee asked that the entire ordinance be reviewed by staff, brought up to modern standards, and brought back to a future Parks and Recreation Committee meeting for review and endorsement before this item move forward to the Board.

Discussion

The amendment would prohibit commercial activities in public parks without permission and prior agreement with the Cameron Park Community Services District

and would allow the CSD to address the individuals and private businesses that might use CSD parks for commercial gain, and to cease use of CSD parks and facilities unless an agreement has been reached between the two parties, executed by the CSD, and that the private party has provided the CSD with a certificate of insurance listing the Cameron Park Community Services District as the additionally insured. In addition, Section 5 has been reviewed and cleaned up to be clear and easily understood.

Recommendation

Staff recommends that the Parks and Recreation Committee review, endorse, and forward to the Board of Directors proposed amendment to Section 5 of Ordinance No. 2001-01 for Board consideration and approval. This would require first and second readings with public hearings.

SECTION 5. Conduct - Generally. It ~~shall be~~ unlawful for any person, within the limits of any Cameron Park Community Services District park, or within any property or facility which is owned, leased, under the control of, maintained or operated by the Cameron Park Community Services District, to do any of the following:

- A. Fires. No person shall make or kindle a fire within any park except in stoves or other facilities specifically provided by the District or in a container/BBQ commercially manufactured for such purposes.
- B. Closed To Public. No person shall enter any park or area of any park which is closed to the public.
- C. Firearms, Weapons, and Fireworks. No person shall carry or discharge any firearm, rifle, pistol, ~~sling shot~~, bow and arrow or other similar device ~~or rocket, torpedo or other type of explosive that launches a projectile~~ without the prior written permission of the ~~general manager~~ General Manager, nor shall any person carry into or use any other object within a park with the intent of disturbing the peace of any person by means of noise or otherwise. This prohibition shall not apply to persons engaging in or traveling to target practice conducted in accordance with appropriate standards of safety at an archery, ~~skeet, or target~~ range authorized and provided by the District for such purpose; nor within the scope of official duties. Any device carried into or used within a park in violation of these provisions is subject to confiscation by any law enforcement officer ~~or duly authorized district employee~~ and, ~~in the event thereof, shall be thereafter~~ such weapons or fireworks shall be disposed of in accordance with the law, including without limitation any applicable District regulation. ~~Persons in violation of this subsection shall be punished as a misdemeanor~~ are subject to arrest and fines by law enforcement.
- D. Alcohol. No person shall possess or consume any alcoholic beverages in any area, park roadway, grounds or recreation center, or in any building or structure, ~~thereon,~~ where it is expressly prohibited and posted as such, without first obtaining a permit to do so from the ~~general manager~~ General Manager.
- E. Noise. No person shall willfully make or continue a loud, unnecessary, or unusual noise or indulge in riotous, boisterous, threatening, or indecent conduct, or abusive, threatening, profane, or indecent language within a park in such a manner as to disturb the public peace

or to materially disrupt the quiet enjoyment of reasonable persons of normal sensitivity who are lawfully present in the park or on nearby properties.

- F. Amplified Sound In Parks. No person shall ~~cause the use~~ amplification ~~of sound equipment~~ within a park if the noise level caused thereby causes discomfort or annoyance to any considerable number of reasonable persons of normal sensitivity lawfully present in the park or disturbs the public peace or materially disturbs the quiet of such persons, except pursuant to a permit issued by the ~~general manager~~ General Manager. Appropriate signs shall be posted advising of any vehicular travel restrictions in force.

This provision does not apply to any electrically driven wheelchair carrying a ~~physically incapacitated~~ person with limited physical mobility.
- I. Skateboards, Skates and Roller Blades. SECTION 5. Conduct - Generally. - A. Fires. No person shall make or kindle a fire within any park except in stoves or other facilities specifically provided by the ~~D~~istrict or in a container/BBQ commercially manufactured for such purposes.
- B. Closed To Public. No person shall enter any park or area of any park which is closed to the public.
- C. Firearms, Weapons, and Fireworks. No person shall carry or discharge any firearm, rifle, pistol, ~~sling shot~~, bow and arrow or other similar device ~~or rocket, torpedo or other type of explosive that launches a projectile~~ without the prior written permission of the ~~general manager~~ General Manager, nor shall any person carry into or use any other object within a park with the intent of disturbing the peace of any person by means of noise or otherwise.
