### **DEPARTMENT MATTERS: GENERAL BUSINESS**

- 2. Station 88 facility relocation (D. Martin) Review and discuss / not an action item
  - DM talked about alternate locations for Station 88. The Rite Aid building in not available. Look at a parcel next to Grocery Outlet that is part of a second phase of a development property the developer is open to having a discussion regarding the sale of 3.9 acres there. The District owns property on Starbuck which could be combined with an undeveloped lot adjacent that could have fire station potential (if that adjacent property is for sale).
  - EA any other potential sites?
  - <u>DM KR identified some smaller lots, but it leaves us in the same situation we are in</u> now.
  - <u>DM new fire station would cost approximately \$8-10 million</u>
  - FWC what do you mean by mixed use?
  - <u>DM that it couldn't be combined with a park or shop, but not all 4-acres would be</u> needed for a fire station.
  - EA we've talked about a park on the north side (Dunbar) do you see any reasons why a park couldn't be located next to a fire station?
  - <u>DM no reason, could be beneficial</u>
  - AP agreed
  - EA next steps
    - Explore property behind Dunbar (and on Green Valley including the property with the old apartment building)
    - Explore grant opportunities
    - o How do we do the rest?
    - Closed session at November 16<sup>th</sup> Board meeting
    - What to do about the current Station 88 building?
- 3. **Equipment** Replacement (D. Martin) discussion only / not an action
  - DM Engine 389 is reaching the end of its lifespan. Things to consider:
    - o <u>How much for a new wildland engine?</u>
    - Cost for maintaining E389
    - o 2-year wait for taking delivery of a new engine
    - o <u>Believes we should plan now for its replacement</u>
    - o Chief Seibert will provide the committee a full report at the next meeting
    - o Resale value for E389 (a Model M) is dropping. Current model is M34.
  - EA look at leave vs. purchase options
- 4. Weed Abatement and Fuels Reduction update (K. Richards) information only / not an action item



- KR CPFD working with El Dorado County Department of Transportation to abate weeds on Sudbury near Pinehill Reserve; some work along Cameron Park Drive between Hwy 50 and Oxford
- DM will be updating weed abatement ordinance
- EA are there any other areas in addition to Cameron Park Drive?
- <u>DM we try to link project areas together</u>
- EA Rasmussen Pond area needs weed abatement for 2023
