### INTRODUCTION

The Board of Directors approved a Preliminary Budget for Fiscal Year (FY) 2022-23 in June 2022. This report summarizes special and reserve fund budgets for your review prior to the Final Budget approval on August 17, 2022.

### DISCUSSION

### Quimby Fund 03

The proposed budget for Fund 03 includes:

- 1. Funds to replace the restroom roof at Rasmussen Park. The lowest bid to perform the work was \$10,864. An additional 10% to replace any unforeseen dry rot on the roof.
- 2. The decking on the observation deck at Cameron Park Lake is worn out. The 2X6 Lumber needs to be replaced. District staff can replace the lumber this winter. This is a best guess estimate. The condition of the dry rot underneath the 2X6 is unknown currently.
- 3. Purchase new fountains for the inlets at Cameron Park Lake. The old fountains are worn out. The new fountains will need to be moved further out in the lake. The original location is to shallow and will not allow for larger fountains to be installed. Staff has not had a chance to price out moving the electrical further down the lake shoreline. The cost is a best guess estimate.

### Fire Training Fund 05

The Fire Training captain Shawn Schmidt put together the budget for the 22/23 Fire training fund to meet the needs of the program.

### Fund 74 Summer Spectacular-Special Events

Starting the 22/23 FY we have implemented a fund to track all revenues and expenditures for the Summer Spectacular. This event is meant to financially sustain itself and this will help staff to ensure the funds raised are being used for this event and if there is a cost savings and additional revenues are received, they can go to fund future events.

### Fund 82 Facilities Reserve

At the direction of Board of Directors the Community Center settlement funds went into their own reserve fund to allow for the appropriate projects to take place. The budget for 22/23 is as follows:

- 1. Roof Repairs \$10,000-The roof repairs will be performed by Cal Vintage Roofing. The district has already solicited quotes from 3 roofing companies to perform work that was called out during the warranty settlement. There may be future expenses to the roof until it is time to have the roof completely replaced.
- 2. Repair Front Entrance- \$93,947- The District is working on obtaining a third bid to repair the water damage to the front main entrance. A scope of work has been sent to several companies. The lowest bid the district has received thus far is \$85,447. 10% was added for any unforeseen issues. The scope of work was created by the law firm who performed a detailed investigation of the Community Center.

### CONCLUSION

For FY 2022-23, staff is providing a budget based on the needs for each fund found necessary. Some of the Funds have a balance that has rolled over from previous years and that is why not all funds balance to \$0 net revenues over expenditures.

### CAL FIRE Amador-El Dorado Unit Training Fund (Fund 05)

CAL FIRE generates funds due to an agreement between CAL FIRE, District, and Lake Tahoe Community College. Amador-El Dorado Unit CAL FIRE employees enroll as students at the Community College, and the Community College pays CAL FIRE for each student's instruction. The District receives and disperses the fees on behalf of CAL FIRE Amador-El Dorado Unit, and receives a 10% administrative fee for managing the funds.
