While members of the public are always welcome at these meetings, the CC&R Committee is currently the only one which includes members of the public. In essence, the committees have served as a venue for the public to vent rather than actually sharing in the direction.

Benefits of Including Members of the Public

- Empower community members with ownership as stakeholders
- Provide the CPCSD with fresh ideas
- Clarify the needs of the residents
- Avoidance of conflicts
- Build an effective ongoing relationship with the community
- Ensure process is open and transparent
- Allow community members become more aware of the decision-making process

Things to Consider

There are several ways to create the new public-included committees, including:

- Request applications from anyone interested
- Provide a leadership school to train the public on the procedure and have the Board members select individuals from this pool


