Fire Department Operations and Administration

- All Fire Department staff continue to prepare and train for the upcoming fire season.
- Intern firefighters have been allowed back and are now signing up for shifts as of May 15th.
- We hired two new Engineers, Brennan Walovich and Casey Peck.

Weed Abatement and Grant Summary

- Reinspections on vacant lots will begin during the first week of June. We are looking at liening 12 possible lots to bring them into compliance with District ordinance.
- Nearly 600 inspections have been done on habitable structures within Cameron Park.
- 2 of the 5 Fire Prevention signs have been installed. The other 3 signs are scheduled to be installed on June 3rd.
- Crews from the Growlersburg Camp along with BLM continue working on a 200-foot fuel break on the Pine Hill Preserve. Both track chippers have been relocated to Auburn Hills Drive and Drummond Way.

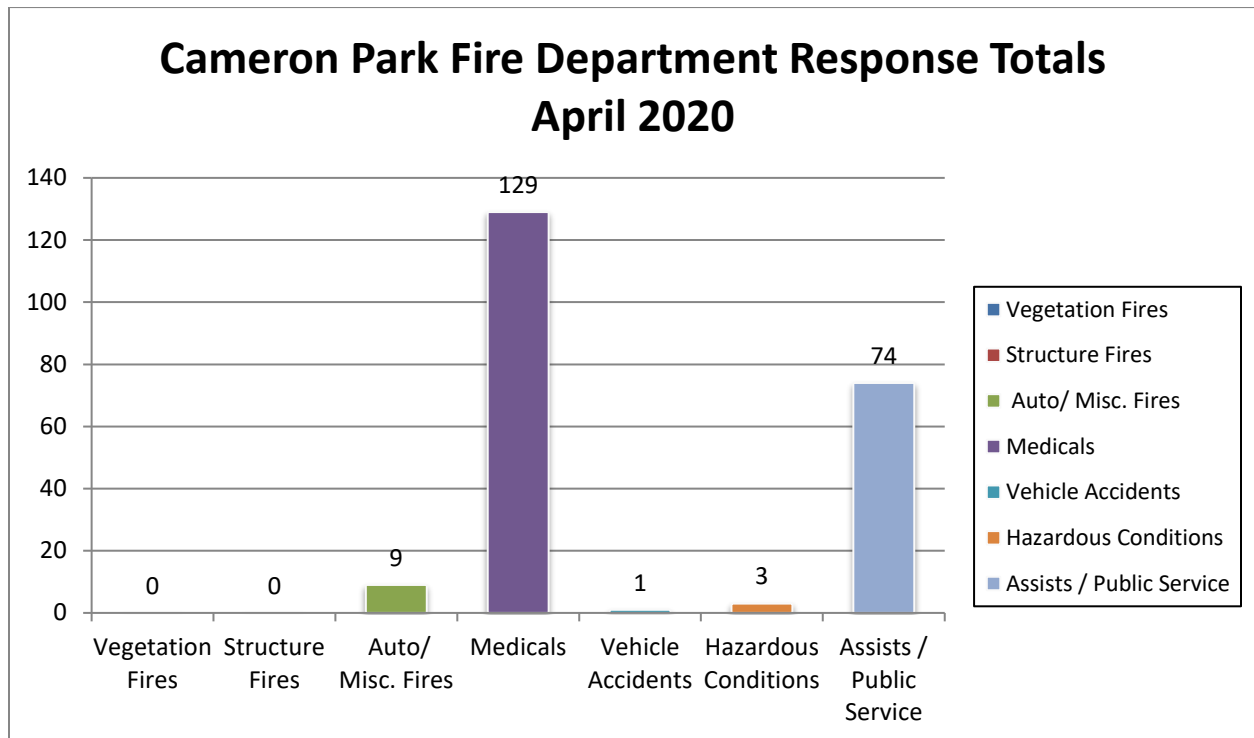

Incidents for the Month of April 2020

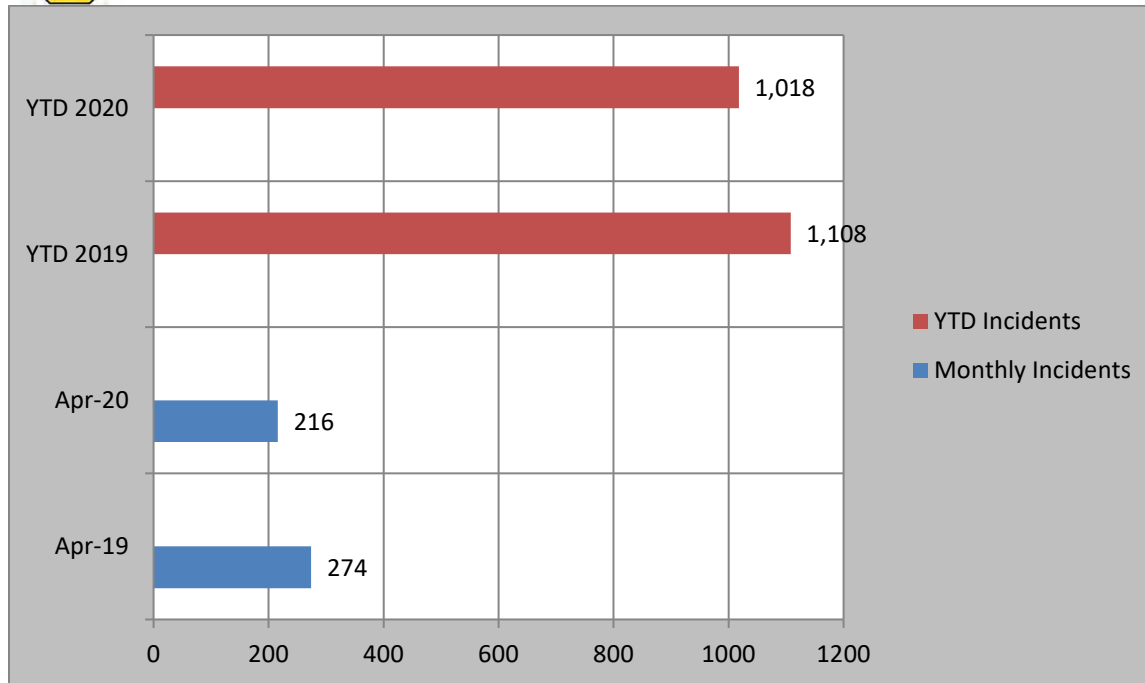


Incidents have decreased by 21% for the month of April compared to April of 2019.

Total incidents have decreased by 8.3% for the calendar year of 2020 compared to 2019.

FIRE DEPARTMENT OPERATIONS AND ADMINISTRATION

Firefighters continue to take extra precautions on all calls. We continue to modify and change our policies and procedures to best protect our staff and their families.

Call volume has continued to decline during the month of April.

Both Fire Stations are still closed to the public. All Fire Marshal and public administrative concerns are being handled via phone or email.

New Engine 88 has been delayed 30-60 days due to COVID-19.

FIRE PREVENTION WEED ABATEMENT SUMMARY

All residents received their Fire Prevention and Education post card and magnet during the month of April. 7,500 were mailed out.

Over 300 vacant lots have been inspected and 200 letters were sent out for noncompliant lots. Reinspection will begin on May 1, 2020.

341 inspections have been done on habitable structures within Cameron Park. Out of the 341 inspections, 20 have failed and will be re-inspected.



CAMERON PARK FIRE DEPARTMENT STAFF REPORT

Submitted for CEQA review for 64 acres of fuels reduction work to be done on Cameron Park CSD owned property. This should be completed by the end of May.

All 5 metal Fire Prevention signs have been installed and are located at Hacienda Park, Gateway Park, Sand Piper (Bass Lake), CP Lake, and CSD

Crews from Growlersburg Camp along with BLM continue working on a 200-foot fuel break on the Pine Hill Preserve. Crews have been cutting, piling, burning, and chipping as they go. This project is supported with funds from the CCI Grant.
