

It was nice meeting and discussing with you again during the project kickoff meeting. Also Mike Grassle, Parks Superintendent, gave us a nice dam tour. Thank you!

We are working on the data collection for the dam break study and like to give you a quick update:

- i. Site visit is completed;
- ii. Digitized the Dam drawings and saved the information in Excel;
- iii. Searched for the Digital elevation model (DEM) data and so far we have got 10 meter DEM data from USGS website. We are still searching for finer resolution DEM data from other sources.

We are making progress on the dam break study and like to give you a quick update:

- Contacted various agencies for the finer resolution DEM data including El Dorado County Surveyor Department and the Department of Transportation.
- Visited the El Dorado County Surveyor Office in Placerville and met Jess Melchor, Senior CADD technician from the County. He promised to provide the following information:
 - HEC-1 model files;
 - HEC-2 mode files (survey cross-sections data);
 - Cameron Park dam watershed study report; and
 - As builds for the subdivision

We have received as builds for the subdivision but yet to receive the remaining information from Jess.
