Introduction

On September 16, 2020, the Board of Directors approved:

- Resolution 2020-21 Approving Application(s) for Proposition 68 Per Capita Grant Funds, an authorizing Resolution required by Office of Grants and Local Services (OGALS);
- Cameron Park Community Services District Park Improvement Plan and Priority Projects, which placed renovating sports fields as a high priority project.

On November 18, 2020, the Board of Directors approved Delta Blue Grass as the vendor for the sports field renovation project.

Discussion

On November 2, 2020, staff provided a report to the Parks and Recreation Committee outlining potential projects for Proposition 68 Per Capita grant funds. Proposition 68 grant funds are designed to improve aging park infrastructure and amenities. In summary, the Parks and Recreation Committee prioritized sports fields, playgrounds and restroom renovations as high priority projects for the Per Capita grant funds.

Staff is recommending that Proposition 68 Per Capita grant funds be used to renovate the District's sports fields at Rasmussen, David West and Christa McAuliffe parks, and have developed the grant applications (Attachments 1A, 1B, 1C). A twenty percent local match is required. Prospector Soccer is agreeable to funding the 20% match for Christa McAuliffe Park. A letter of agreement will be developed between the District and Soccer to specify expectations for the project, role of each organization and funding sources. Motherlode Rugby also met with the District staff. Ponderosa Little League responded to the District's request to meet, which will be taking place soon.

The renovation project(s) will take place once funding is secured. The project at Christa McAuliffe Park may occur this Spring 2021.







AGENDA ITEM #2: BRIGHTON ENERGY'S ENERGY EFFICIENCY UPGRADE – PROJECT

OUTCOMES

RECOMMENDED ACTION: RECEIVE AND FILE

INTRODUCTION

On February 7th 2020, ARC consultants reviewed 2 energy efficiency project proposals on behalf of the District. These proposals were in response to upgrading the existing interior and exterior lights at the community center to energy efficient LED lights. This plan was supported by the Solar Energy Ad Hoc Committee. Installing energy efficient lights would lower energy use and assist in building an appropriate sized solar project system. This upgrade would also save on energy costs, as well as significantly improve the lighting. The new LED lights are self-contained units, notably reducing maintenance costs. The District awarded the contract to Brighton Energy on May 19th 2020 to upgrade the lights at the community center. Brighton Energy was on the state procurement list, making the formal bid process less restrictive. In addition to the Community Center, Brighton Energy was awarded a contract to replace all existing lights at Fire Station 89 with energy efficient LED fixtures.

Community Center

All of the lights at the community center were replaced, with the exception of the underwater pool lights and stage lighting. This project started on June 17th, 2020 and was completed on October 2nd, 2020.

- **Original project,** with 2 change orders; adding battery backups to the emergency lighting and additional lighting that was missed in original estimate. Funding for this project came from an OBF (On-Bill Financing) with PG&E.

o Loan total: \$45,205.49

Loan term: 64 months, 5.33 years

o Fixed monthly loan payments: \$706.34 (\$8,476.08 annually)

Estimated annual energy cost savings: \$8,635.77

o Return on investment: 5.23 years

- **Assembly hall chandelier lights,** this change order was funded by community center reserves, because the project was not eligible for OBF.

Total cost of project: \$8,998.13

Estimated annual energy cost savings: \$866.04

o Return on investment: 10.39 years

Fire Station 89

All of the lights at Fire Station 89 were replaced, funding for this project came from the fire department reserves. Project started on August 24th, 2020 and was completed on September 4th, 2020.

- Total cost of project: \$14,033.99

- Estimated annual energy cost savings: \$3,084.12

- Return on investment: 4.55 years

Conclusion

The quality and brightness of the new LED lights is quite remarkable. The exterior of the Community Center is very bright, and all of the light fixtures are working. The longevity of the new LED lights is longer, creating efficiency in staff maintenance costs for replacing bulbs, especially when a ladder or hydraulic lift is required. This project will save the District approximately \$20,000 annually in electrical bills once the financing is paid-off. If the District converts to solar, this project helped in downsizing the solar project required to power the District's facilities.

General Update

Gymnasium Operations

The Department spent the month of November recalibrating due to El Dorado County moving back into the most restrictive Purple Tier. Most activities can proceed, but the gym closed as of November 29. This is news was very disheartening, as facility rentals remains the primary source of revenue generation. Staff remain hopeful that the gym rental may resume in mid-late January and have plans to do all that they can to ensure the gym is utilized to full capacity for the remainder of the fiscal year.

Annual Early Bird Combo/Lake/Pool Passes

Staff are developing a new plan for the new Annual Pass that will be sold beginning in January of 2021. This plan includes a mailer sent to all residents to encourage purchasing the new pass that will help support both the Parks & Facilities and Recreation Departments. Our goals include:

- ✓ Streamlined fee schedule,
- ✓ Outreach messaging that is "support District parks and facilities, Buy an Annual pass,"
- ✓ Value-Added with pass holder events and specials to be announced this spring,
- ✓ Open the kiosk more days and for a longer season.

Training

- Kimberly Vickers, Recreation Coordinator is now a certified Aquatics Facility Operator, which is in addition to her array of lifeguard certifications.
- Whitney and Kim attended California Park and Recreation Society's Region 1 CARES Virtual Conference held November 16th 20th; topics primarily related to facing the

Global Pandemic and an opportunity to network with other professionals in a time we cannot do so in person.

Current Programming

- Lap Swim at the pool continues to receive positive feedback from the regular participants and average attendance numbers remain stable (7-10 swimmers per session 6 days a week)
- Five people participated in the Bird Watching class held at Cameron Park Lake.
- Six little ones participated in our Skyhawks Soccer Tots class at Christa McAuliffe.
- The Christmas Craft Fair Connections website has received positive feedback from both vendors and shoppers alike. 18 vendors registered.
- Virtual Recreation Center program opportunities expanding to provide residents new engaging and fun entertainment.

Upcoming Events

The County has approved the following events for this holiday season,

- Virtual Tree Lighting at Christa McAuliffe on Friday, December 4th at 5:30p via Facebook Live.
- Snap a Selfie (drive-thru) with Santa on Saturday, December 12th and Sunday, December 13th at Rasmussen Park.
- The Cameron Park Fire Department developed the Santa Parade with a new route same days as the Santa photos and staff will promote both Santa events jointly on social media.
- Holiday Dunk and Dive! At the pool on December 19th from 12:30-2:30p; open swim, candy cane dive and hot chocolate
- Noon Year' Eve on December 31st 11:00am- 12:30pm with open swim and a "beach ball drop" at noon.

New Staff Assignments

AGENDA ITEM #3B: PARKS & FACILITIES DEPARTMENT REPORT

General Information

- The Department has begun utilizing the District's new utility dump trailer to remove leaves from District property. Staff labor has been reduced with the addition of the new trailer.
- Staff fertilized all of the turf grass for the winter season.
- Staff have been spending some time repairing damaged equipment. Most notably staff repaired a hydraulic pump on the department tractor, saving the District a substantial amount of money
- The department has implemented a work order and asset inventory software. The majority of the District assets have all been logged within the software. This will give the District an accurate inventory with cost, location, life span, maintenance schedule and serial numbers for all assets. (Does not include the fire department).
- Staff started locating and mapping out irrigation systems throughout the LLAD'S. This will allow staff to check, repair, irrigate and locate the systems more efficiently.
- Staff installed new trailer brakes on all of the ¾ ton and 1 ton District vehicles. Having the brakes installed will allow staff to haul heavy materials with the new dump trailer.

Cameron Park Lake

• Staff continue to construct the perimeter fence around the Cameron Park Lake Disc Golf Course. Staff are also installing two culverts to help divert water into Deer Creek.

Parks and LLADs

- The department rented a hydraulic lift to decorate the Christmas tree at Christa McAuliffe Park prior to the virtual tree lighting event.
- Staff repaired a section of the large slide at Christa McAuliffe Park that had cracked due to wear and tear.
- The rock climbing wall at Rasmussen Park has cracked and is warped beyond repair. The department has order a different climbing amenity to install in its place.
- Cal Fire has been utilizing a contractor to perform some fire fuel reduction work at Royal
 Oaks Park. Low lying brush and dead/hazardous tress have been removed. Royal Oaks
 Park has never looked this good.

Community Center

- El Dorado County Election Department utilized the main hall as a voting center starting on Saturday October 31st through Tuesday November 3rd.
- Staff noticed a large leak on the gym roof. The leak was due to a repair in the past that failed. Gudgel/Yancey Roofing has since repaired the leak.
- Hillyard Janitorial resurfaced the gym floor the first week in November. This is a maintenance practice that needs to be performed every 2-3 years moving forward.

Cal Fire / Growlersburg

• The District received crews over the past month. Crews spent their time assisting staff with the installation of the perimeter fence at the Cameron Park Lake Disc Golf Course. They also spent a day cleaning up the shore line at Cameron Park Lake.
