The committee moved to add it to the April F&ES committee meeting to discuss a plan to support the creation of Firewise communities in Cameron Park.



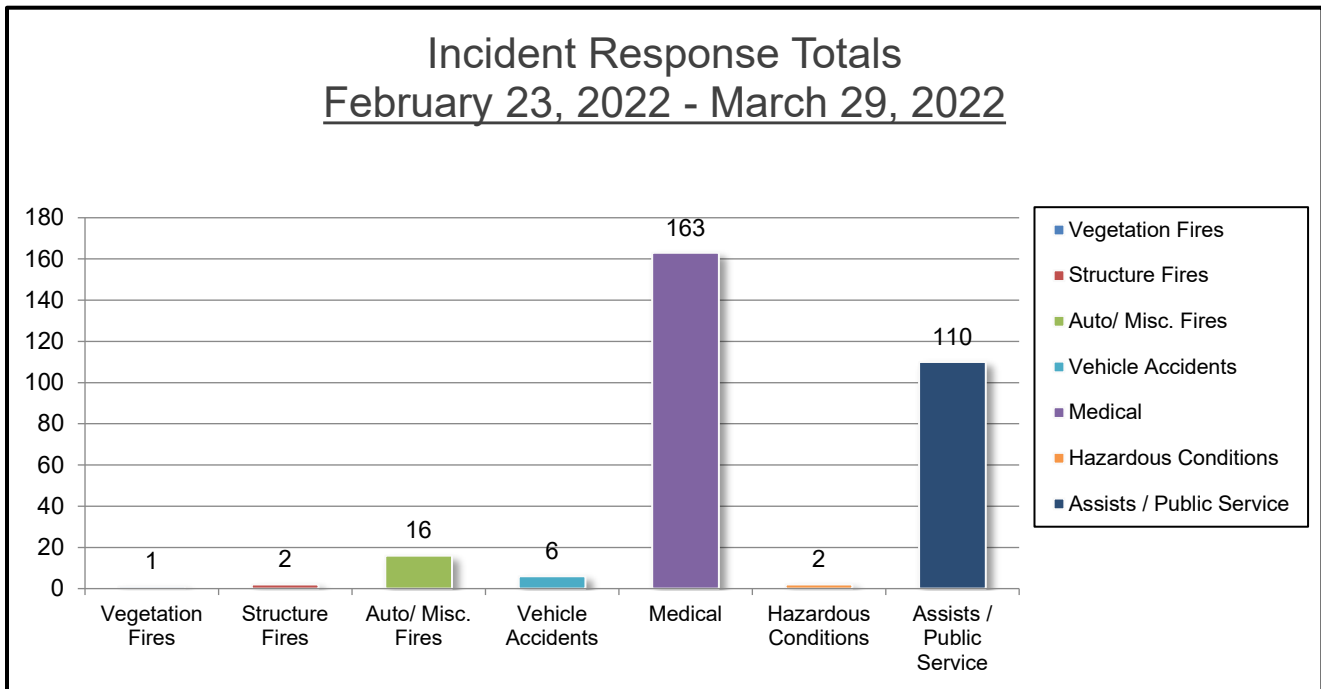
